Transit Development Plan

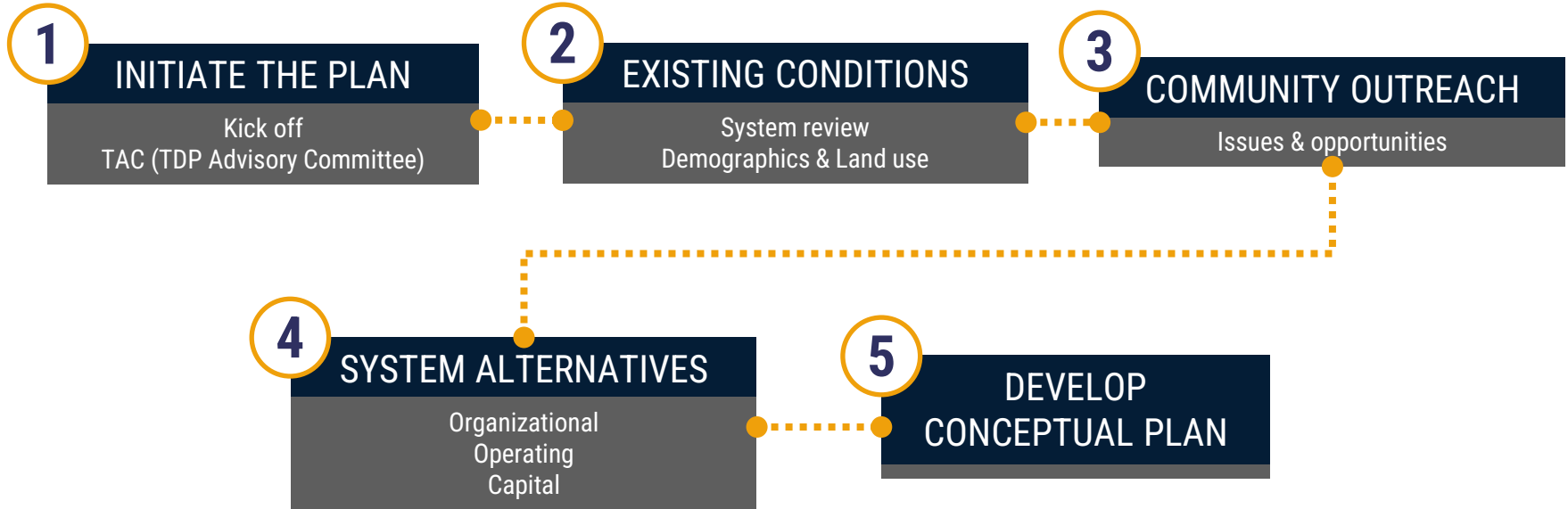
- Short-term (5-Year) plan
- Guides the growth of public transit
- Defines goals and objectives
- Identifies needs and potential improvements
- Used as a basis for future federal & state funding



2018 Central Maryland TDP

- Performance and service improvements for the existing transit system
- Bus route system reconfiguration and service expansions (two phases)
- Three year+ vision for service expansions
- Addressed the high cost and rising demand for demand-response services

- Endorsement of the TDP prior to submission to Executive and Council



TDP Advisory Committee Role

- Committee comprised of Howard County staff, RTA, MTA and KFH Group
- Provide input on study goals, transportation needs and service strategies
- Assist in data collection and outreach
- Provide project deliverables prior to presentations to public boards

TDP Goals

1. Increase ridership
2. Study and implement Bus Rapid Transit
3. Enhanced public transit circulation in Columbia
4. Enhance transit options along Route 1 corridor
5. Evaluate alternatives from previous TDP
6. Study a direct connection between Elkridge and Columbia
7. Explore transition towards electric buses
8. Set realistic performance goals and service improvements
9. Ensure regional coordination

Existing Conditions Analysis

- Currently in progress
- Full review of RTA service and operating environment
- Regional connections
 - ▶ 63% of Howard County's commuters work within the RTA service area
 - ▶ 40,000 people commute between Anne Arundel and Howard County
 - ▶ Strong connections to Montgomery, Prince George's, Baltimore, and DC
